Organization and Partner may be referred to individually as "Party" and collectively as the "Parties."

WHEREAS, Organization is a technology company that connects partners and rural/tribal communities to benefit each other in many ways.

WHEREAS, Organization is supporting beneficiary campsites at DARAITAN, TANAY RIZAL, PHILIPPINES owned by various local and tribal families to bring new hope and livelihood.

WHEREAS, Partner would like to join Organization and acknowledges and agrees to be bound by the terms and conditions listed herein;

NOW, therefore, in consideration of the promises and covenants contained herein, as well as other good and valuable consideration (the receipt and sufficiency of which is hereby acknowledged), the Parties do agree as follows:

1. PARTNERSHIP

This Agreement forms a legally binding agreement between Partner and Organization and governs the Partner's access and use of the Organization's services and physical facilities.

2. PARTNERSHIP SERVICES

The Partnership Services provided by the Organization include the use of the Organization's physical facilities at the following address:

Campsite Headquarters: Sitio Masayo, Daraitan, Tanay, Rizal (14.6090305,121.4215904) and other campsites associated with it.

The Partnership Services provided by Organization are as follows:

- Free 2 nights overnight stay monthly using our in-house tent (use of in-house tent is only allowed for a minimum of 4pax)
- Free 2 nights overnight stay monthly using own tent in our tent pitching area (no minimum pax limit)
- Access to all campsites with unlimited day trips
- Free use of common facilities
- Access to farm picking & farming activities (once available)
- Can bring non-partners for a daily rate of P250 (day trip) and P1,000 (overnight)
- Signing privileges – our site is cashless so billings are sent to you after your trip
- 30% discount on activities and other services
- Priority list during special events & activities

In-House Tent Policy

Our 17ft in-house bell tent can only be used with a minimum of 4pax. ***If the Partner is staying below 4pax***, this mean that the Partner will have to pay for the remaining pax at a discounted partner rate of 1000 PHP/night.

Example Scenarios:

- *1 partner will stay in one tent will need to pay for the remaining 3pax*
- *2 partners will stay in one tent will need to pay for the remaining 2pax*
- *2 partners will stay in 2 tents will need to pay for the remaining 6pax*

Own Tent Policy

There is no minimum pax if you pitch your own tent in the campsite. You can simply pitch your tent without any fees. However non-partners will still need to pay a discounted partner rate of 1000 PHP/night.

Day Trip Policy

Only partners are allowed to spend day trips at Bulod at no cost. However your companions are required to pay 250 PHP/person.

3. FEES

Partner will be responsible for the payment of fees ("Fees") to the Organization as follows:

- Annual Fee: P10,000 (VAT Exclusive)
- Validity: 12 months

5. PARTNER CONSENTS

Partner agrees to hold the Organization, its owners, affiliates, and representatives, harmless from any damage, whether tangible or intangible that may happen to Partner and companions while participating in the Partnership Services.

Partner agrees that the Organization offers its partnership program with no guarantee of results of any kind. Partner agrees that any results that occur during their partnership, whether positive or negative, are the effects of Partner's own personal choices.

Partner agrees and verifies that all of the information they have given the Organization and its representatives is accurate, up to date, and without the omission of any requested information.

Partner agrees and verifies that even if they have omitted any necessary personal information, whether knowingly or unknowingly, they will hold the Organization harmless against all liability for any damages that may occur to Partner or others because of Partner's actions or inactions.

Partner agrees to notify the Organization Partnership Team of any changes or upcoming changes concerning their personal information.

Partner and its companions agree to book online (<https://bulod.camp>) and agree to Bulod's Terms & Conditions, which includes general house rules and a WAIVER.

6. ASSUMPTION OF RISK

Partner agrees and understands that their participation in the Partnership Services may involve risks.
